- Fair Associate Members will have their own meetings to discuss improvement, event scheduling, work days, and fair preparation. A member of the Fair Associate Committee will be in attendance of these meetings & will be there for guidance and questions.
  
- Fair Associate Members should be able to volunteer time before, during and after the fair.
  
- Any complaints, questions, suggestions, or improvements of this Board will go through the Fair Associate Membership Committee
